They are hell-bent on cutting good jobs at a time of record unemployment in a bid to privatize the Postal Service and put tens of thousands of workers - many of whom are African American - out of work. This cannot happen in the age of Occupy. Donahoe cannot be allowed to attack workers without being confronted and challenged by the 99 percent.
