## (U) Occupy Movement National Gathering

### Scope

(U//LES) The Bureau of Alcohol, Tobacco, Firearms & Explosives (ATF), Office of Field Operations, Philadelphia Field Division, has prepared the following Advisory to provide information and analysis on the upcoming Occupy Movement National Gathering in Philadelphia. An ATF Advisory is a summary of criminal threat information reported to ATF either by civilian source or local law enforcement and at least partially vetted for sourcing that could constitute a criminal threat to officer safety or the general public.

### Key Findings

(U//LES) From June 30th to July 4th, the Occupy movement will convene the Occupy National Gathering in the vicinity of Philadelphia's Independence Mall.<sup>1</sup> According to a statement released Monday, the gathering in Philadelphia will involve "direct actions, movement building and the creation of a 'blueprint' for a democratic future."<sup>2</sup> Numerous protests and disruptions are planned around the city.<sup>3</sup>

### Background

(U//LES) The Occupy movement is an international protest movement against social and economic inequality, its primary goal being to make the economic structure and power relations in society more favorable to the under classes. Different local groups have different foci, but among the prime concerns is the claim that large corporations and the global financial system control the world in a way that disproportionately benefits a minority, undermines democracy and is unstable.

Occupy Wall Street (OWS) was initiated by the Canadian activist group Adbusters, and partly inspired by the Arab Spring, especially Cairo's Tahrir Square protests, and the Spanish Indignants. The movement commonly uses the slogan *We are the 99%*, the #Occupy hashtag format, and organizes through websites such as Occupy Together.<sup>4</sup>

The first Occupy protest to receive wide coverage was Occupy Wall Street in New York City's Zuccotti Park, which began on September 17, 2011. By October 9, Occupy protests had taken place or were ongoing in over 95 cities across 82 countries, and over 600 communities in the United States. Although most popular in the United States, Occupy has seen protests and occupations in dozens of other countries and on every continent. For the first two months of the protest, authorities largely adopted a tolerant approach towards the movement, though this began to change in mid November with over a dozen camps being cleared in both the US and Europe. By the end of 2011 authorities had cleared out most of the major camps. The last remaining high profile camps - at Washington DC and at St Paul's Cathedral in London - were cleared by February 2012.

- At least 105 occupy groups from around the country have registered to take part in the Gathering in Philadelphia
- Occupiers will be setting up tents and sleeping bags to camp out on Independence Mall as well as utilizing nearby churches and shelters
- Protests and civil disobedience activities are planned around the city
- Occupy National Gathering is encouraging occupiers to register all of their vital information with their legal collective upon arriving so they may track all of the individuals who are planning to be arrested once they arrive to jail
- Occupiers are being encouraged to pack light and prepare to be on the move in the event of police aggression

**Conclusions and Recommendations**

(U//LES) From June 30th to July 4th, the Occupy movement will convene the Occupy National Gathering in the vicinity of Philadelphia's Independence Mall. Numerous protests and disruptions are planned around the city. Citizens should remain vigilant and plan for increased traffic and disruptions around the Independence Mall area. Although there is no indication that acts of violence will occur, take appropriate precautions as some of these groups have demonstrated violence in the past.

**Intelligence Gaps****(U//LES)**

- Are there any planned threats towards government facilities or banking institutions?
- What effects will the Occupation have on families planning to visit for the Fourth of July activities?
- What effects will the Occupation have on public transportation?
- Have any permits been obtained by the Occupation?
- Have departments planned to have enough presence and holding facilities should conflict occur?

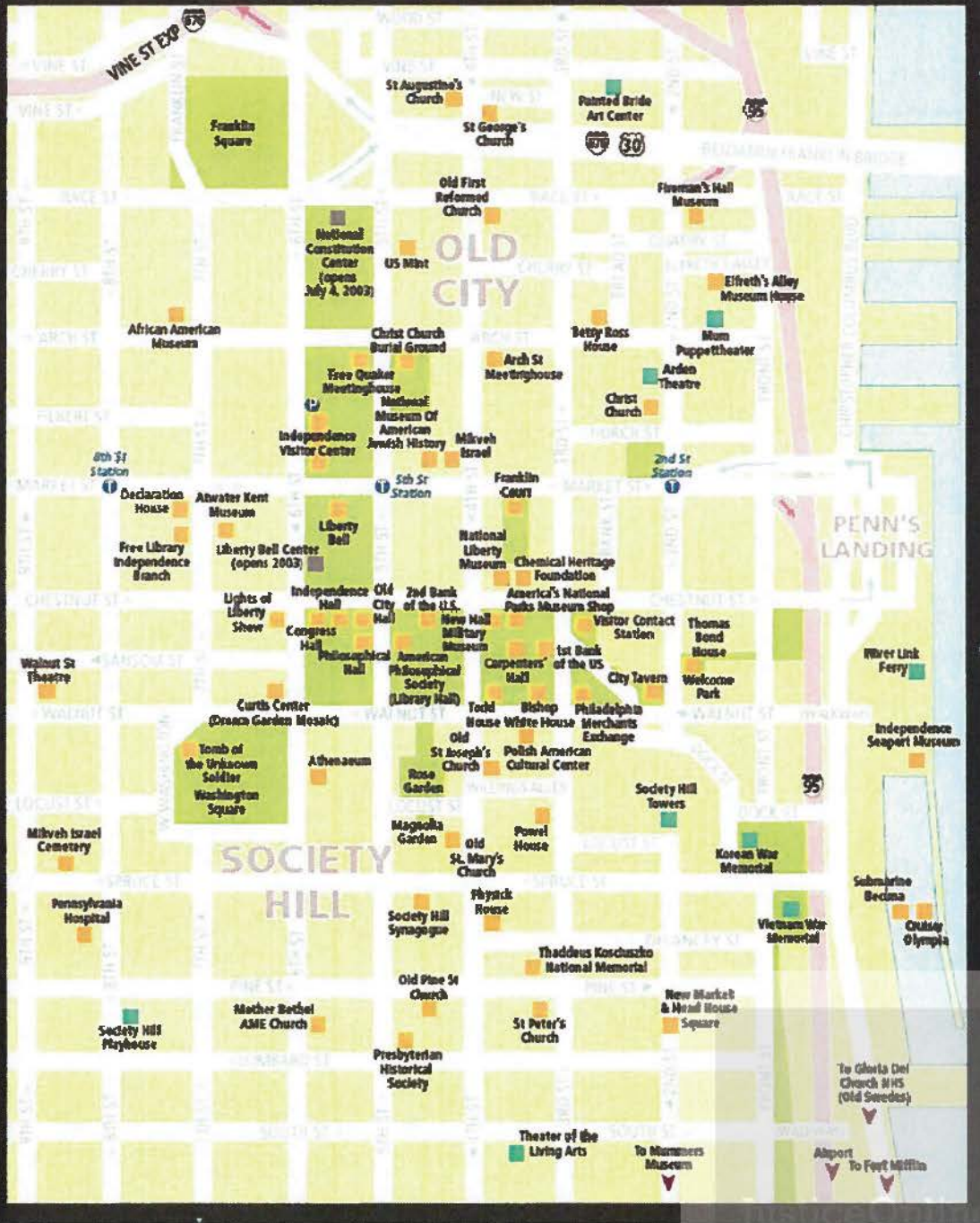

**Information gained from research into violence perpetrated during Occupy protests**

On October 6<sup>th</sup>, 2011 a protest calling itself Occupy New Orleans occurred. There have also been "Occupy" protests in Shreveport and Lake Charles. There is an Occupy Baton Rouge protest scheduled for October 22, 2011. These protests are part of a larger, Nation Wide movement in support of the Occupy Wall Street protest and the movement appears to be spreading overseas.

An RFI was submitted to 70 State Fusion Centers and ATF IRS' nationwide requesting ATF relevant information on any crimes that occurred during "Occupy" protests. Below is specific information provided in the responses, media covered instances of violence, from social media websites and analysis on possible scenarios for violence.

This paper is not all encompassing; its intent is to capture the average risk to Law Enforcement and the civilian population.

**Information provided via RFI response:**

- Connecticut – No violence.
- Kentucky – Pending, received Arizona Fusion Center Product
- Pennsylvania – No violence.
- Vermont – No violence.
- Illinois – No information received about any criminal incidents.
- Maine – (MIAC) No violence. Provided New Jersey Products.
- New Jersey – No violence.
- ATF Charlotte FIG – No violence.
- Boston – RFI should be made to Boston Police Bureau 617-343-4300
- Virginia – (NVRIC) Provided Virginia Intelligence Product.
- ATF Louisville & Lexington KY – No violence. (b) (7)(E)

- North Dakota – No violence.
- Boston Massachusetts – No intelligence products produced. Supplied Boston P.D. bulletins.
- Minneapolis – (MNJAC) No violence. Police and Sherriff's Office producing reports. MNJAC states cold weather could cause protestors to violate the no tent or enclosure





order. Some Twitter and Facebook postings are urging people to not talk with police or cooperate.

- California – “The STAC is not monitoring the “Occupy” protests, and we have no information regarding “Occupy” related violence directed against law enforcement officers.”
- West Virginia – 10 “Occupy” protests are planned. No violence reported.
- North Carolina – No violence, passive resistance with arrests.

#### Social Networking

- Facebook – There are currently two Facebook Pages and three groups titled Occupy Baton Rouge with a combined membership total of 487 people (there may be less as people can join several pages and groups).
- Twitter – 102 “followers” It appears only one person is posting for the account.

\*\* Instances of violent speech and anti Law Enforcement on social networking sites appears more frequently than at the "Occupy" protests. This could be due to a certain feeling of anonymity provided by the internet.

**Possible scenarios for violence at Occupy protests:**

Based on the overwhelming negative responses it is highly unlikely the "Occupy Baton Rouge" protest will result in violence against Law Enforcement. Passive resistance and trespassing will most likely be the lead reasons for arrests. Requests for ATF support are not likely unless the situation escalates dramatically with the use of firearms, incendiary devices or explosives.

There are several scenarios where escalation to violence could occur.

1. The Occupy protests are infiltrated by violent homegrown groups such as ALF, or ELF.
2. Lone wolf targeting of large groups. This scenario is worrisome as this would cause mass casualties if conducted at one of the larger protests.
3. Foreign terrorist targeting of large groups. The Occupy protests present a target that would capture international media coverage as well as provide a large number of casualties.
